"We are committed to continuing negotiations," Carr, board president, said at Tuesday's School Board meeting. She noted, however, that the failed negotiations were a "textbook case" of a broken K-12 funding system and a "deep overreliance" on local property-tax levies to fund education.

- What does the above statement mean to you?

"It's disappointing that the school board is grasping at legalistic straws rather than focusing on ways to provide the supports that educators need to be successful with students," Knapp said in

a statement earlier this week. “We won’t be scared into abandoning our commitment to winning a fair contract.”

- Is the district supporting their educators and helping them be successful with their students? Why or why not?

Seattle City Councilmembers Kshama Sawant, Nick Licata and John Okamoto also urged the School Board to vote against considering legal action. In a letter to the board, they said they believe that the union’s proposals are reasonable, and in the best interest of Seattle students. “However, regardless of one’s opinions on the union’s demands, the educators’ democratic right to speak out, organize unions, and go on strike must be defended,” they wrote.
