Additional Activities

- 1. Have students discuss what it means to "profile" someone. Then ask students to discuss what "racial profiling" is. Have students discuss whether they have ever been stopped by police, or some other person of authority based on specific characteristics like race or been a witness to racial profiling. Then have students answer the following questions: What personal rights does racial profiling violate? Why do you think racial profiling is used? Do you think there are any benefits to using racial profiling and if so what? What dangers do you think are associated with racial profiling?
- 2. Do you agree with the way Khairuldeen Makhzoomi was treated by the airline and the authorities involved? Do you think the woman sitting in front of him was justified in reporting him to the plane's crew why or why not? What would you have done if you were the woman and in the same situation? What would you have done if you were Makhzoomi? In the article Makhzoomi said he was afraid, and that the employee spoke to him "like I was an animal." How would you feel if someone spoke to you "like an animal"?
