Wednesday's News Break selects an article from the Monday, December 5, 2016 print replica of The Seattle Times for an in-depth reading of the news. Read the selected article and answer the attached study questions. Please remember to always preview the content of the article before sharing with your students.

Article: Dallas case tests free-speech rights of a social media troll (Main, A11)

#### Objective:

Students will analyze the first amendment rights by analyzing how it plays a role in current events.

#### Standards:

Analyze the interactions between individuals, events, and ideas in a text (e.g., how ideas influence individuals or events, or how individuals influence ideas or events).

#### **Pre-Reading and Vocabulary**

What does it mean to have "free speech" in America? Why is free speech protected? Do you think that there should ever be a limit to protected free speech? Why or why not?

- 5) How many days in jail was Taherzadeh sentenced to in September of 2015?
- 6) When is the First Amendment's protection of free speech limited?
- 7) What constitutes a "true threat"?

### **Group Discussion Questions or Extension Activity:**

- "He says many people say things online they wouldn't say to someone's face, even pointing to President-elect Donald Trump's tweets as an example."
  - How do you feel about this statement? Do you agree? Should this be the case? Why or why not?
- "You come to America, you think it's all about freedom and stuff and you criticize a judge and you're in jail. I mean, is it only for white people?"
  - Why do you think that Taherzadeh believes this? Is he right? Why or why not? Do you think that Taherzadeh should be in jail for what he did?
- Search the rest of the newspaper (or the archives of the print replica) to see what other examples of news stories you can find that involved the first amendment. Keep track – how many did you find? How are the stories similar? How are the stories different? Do any of the stories change your perspective on the initial article?
