### **Comprehension:**

## **Post-Reading:**

## After reading the article discuss the following questions:

What is the difference between a refugee and an immigrant? How are these groups similar? What do you know about the Trump's executive order on immigration? What do you think about it? Do you think that cities should be able to designate themselves as "sanctuary" cities? Why or why not?

As you ask questions of the class, call on student volunteers to summarize or recall what the previous speaker said.

#### **Building Language Skills:**

Have students write one word or phrase that they think summarizes the main idea of the article. In small groups, have students share their words/phrases. Each small group should choose (or create) one word or sentence that the group thinks summarizes the main idea of the article. Each group should then present and explain their reasoning behind their selection to the rest of the class.

## **Comprehension Question Answers:**

- 1. Their immigration or refugee status
- 2. That the city will reject any offer from the federal government to enter into an agreement authorizing Seattle police officers to carry out immigration enforcement
- 3. An executive order
- 4. Sanctuary cities
- 5. Asking about a person's immigration status unless otherwise required by law or court order
- 6. When they have reasonable suspicion to believe that the person has been previously deported and has committed a felony
- 7. If another city is allowing or even contemplating allowing its officers to carry out immigration enforcement
